**ALL MEMBERS OF THE COUNCIL  
WHO HAVE NOT RENEWED THEIR MEMBERSHIP FOR 2012 - 13**

Dear Members,

This has reference to the Council's Circular Ref. No. GJC / P / RNW / 2012 - 13 dated 20<sup>th</sup> March, 2012 regarding renewal of membership on or before 30<sup>th</sup> April, 2011, for the year 2012 - 13.

The Committee of Administration vide its meeting held on 18<sup>th</sup> June 2012 has extended the period of renewal of membership till 30<sup>th</sup> June 2012 without the payment of admission fees of Rs.5000/- (Rupees Five thousand only + service tax).

If membership fee for the year 2012 - 13 is not paid on or before 30<sup>th</sup> June, 2012, then Council will be constrained to issue a show-cause notice as on 1<sup>st</sup> July, 2012, which should be replied by members on or before 31<sup>st</sup> July, 2012, as to why the membership and Registration - cum - Membership Certificate should not be cancelled.

In case of receipt of the fees on or after 1<sup>st</sup> July, 2012, the Council shall call for fresh application with the signature of Proposer and issue a fresh certificate as Associate / Ordinary Member, as the case may be, and also charge admission fee of Rs.5000/- (Rupees Five thousand only + service tax). In such cases of fresh application for membership a fresh application for RCMC will also have to be filed by the applicant.

It may also be noted that the Ordinary Members who have not renewed their membership on or before 30<sup>th</sup> April 2012 will not be eligible for voting rights and their names will not be included in the Electoral roll.

Please note that it is in your own interest and in interest of your trade and for smooth exports that you are required to pay arrears of subscription fees immediately upon receipt of this Circular and also for avoiding cancellation of your Membership and RCMC which may adversely affect your export efforts.
