- The Council reserves the right to reject any Application Form submitted by the Applicant for the Event, without assigning any reason whatsoever and every such decision of the Council shall be final.
- An Application Form which is not accompanied with the full Registration Fees, pursuant to the applicable category, shall be rejected.
- The Council reserves the right to temporarily or permanently suspend entry of any Applicant to any of conference(s) forming part of the Event for security reason as may be deemed reasonable and necessary.
- Entry is strictly prohibited for minors (i.e., below 18 year of age).

- Cash Payment will not be accepted for Pre-registration. For On-Spot registration, cash will be accepted only at the Venue only on 1st & 2nd December, 2017.
- The Applicant shall not be allowed to record any conference(s) forming part of the Event, whether in part or in full and if any such recordings come to knowledge of the Council, in such cases the Council shall be free to confiscate every such recordings and the equipment's used for such recordings. The Council shall also have the right to cancel the registration and seize the badge(s) of the Applicant(s) thereby not allowing the Applicant(s) to participate in the Event.
