We would like to inform all our members that the Office of the Assistant Commissioner of Customs, Diamond Plaza Customs Clearance Centre, 191, Dr, D.B. Marg., Mumbai has issued a letter No.CRA/CTH-71/Review/DPCC/AM-46/2009 dated 11.08.2010 of the aforesaid subject.

In this regard, they informed us that the Customs Receipt Audit, Mumbai has dropped their objections in respect of import of Gold Mounting and Findings. 
