- b. Diamond, Gemstone & Other Studded Jewellery
- c. Silver Jewellery, Artefacts & Gifting Items
- d. Loose Stones & CVD
- e. Laboratories & Education
- f. Machinery/Allied Section (application and allotment will be done at later date)

**The allotment of the applicants will be based on their GJEPC Membership status as of 16<sup>th</sup> May 2022**

Allotment of Preference to Applicants in each category will be as per below:

**GENERAL PREFERENCES FOR EVERY CATEGORY**

- A. Ordinary Members will have 1<sup>st</sup> preference in the allotment of booths.**
- B. Members having manufacturing units registered under Udyog Aadhar Number (UAN) / SSI with the Council will get 2<sup>nd</sup> preference in booth allotment.**
- C. Associate Member will get the 3<sup>rd</sup> preference in each respective category of allotment/s.**

**The chronological order for allotment will be as follows:**

- a. Less Area
- b. Same Area Different Location
- c. More Area
- d. New applicants

**Participants who had been allotted stalls at the IIJS Premiere 2020 & had participated at IIJS Premiere 2021 in BIEC Bangalore will be considered for IIJS Premiere 2022 and will be allotted booths based on their stall allotment (stall size) as was done for IIJS Premiere 2020**

- D. First Preference: Companies opting for Less area as compared to IIJS Premiere 2020**  
Allotment to Companies who opt for less area as compared to their area in IIJS Premiere 2020 will get first preference (based on their membership type as mentioned above).
- E. Second Preference: Companies opting for the same area as per IIJS Premiere 2020**  
Companies that are applying for the same area as per IIJS Premiere 2020 will get a second preference (based on their membership type as mentioned above).
- F. Third Preference: Companies opting for more areas as per IIJS Premiere 2020**  
Companies that are applying for more areas as per IIJS Premiere 2020 will get a third preference (based on their membership type as mentioned above).
- G. Fourth Preference: Waitlisted Applicants, if any.**
- H. Fifth Preference: New Applicants (applying on or before the deadline)**  
New applicants who have applied & submitted the application form on or before **Monday, 16<sup>th</sup> May 2022** along with the requisite payment of 50% of participation cost will get fourth preference in allotment

Members are informed that application for more areas does not guarantee confirmed allotment. The no of booths to be allotted to applicants will be based as per application submitted & booths will be allotted as per the availability.

**Guidelines:**

- I. **Online Space Application:** All applicants are required to compulsorily submit the online space application form before **Monday, 16<sup>th</sup> May 2022**, and send the application, payment, and declaration to complete their participation formalities.
- J. **Display of Products:** The display of Loose Diamond & Color stones in the Jewellery Section is not allowed. Similarly, No Jewellery in Loose Diamonds & Color stones Section will be allowed. (Beads in Mala form will be allowed in the Loose stones section)
- K. **Booth Allotment:** Booth allotment will be undertaken section-wise & from higher to lower space as per availability and through a lottery basis. No further changes/modifications in space will be accepted after submission of the online space application form and before booth allotment.

**Points to Note:**

- L. Renewal/Application of Membership for FY 2022-23 is mandatory to be completed by 30<sup>th</sup> April 2022. Mere submission of the online space application form and submission of payment without renewal of membership does not qualify any company to become a bonafide exhibitor and their participation will be cancelled.
- M. All the stalls at IIJS Premiere 2022, IIJS Signature 2023, and IIJS Tritiya 2023 will be built-in stalls in the **Maxima** system.
- N. No RAW space / Duplex Stalls options will be there/allowed to be built.
- O. All the interested members are required to submit their Online SPACE APPLICATION for participation at IIJS Premiere 2022 or THREE-SHOW PACKAGE on or before 16<sup>th</sup> May 2022
- P. Participants who had been allotted stalls at the IIJS Premiere 2020 & had participated at IIJS Premiere 2021 in BIEC Bangalore will be considered for IIJS Premiere 2022 and will be allotted booths based on their stall allotment as was done for IIJS Premiere 2020
- Q. All members who had participated first time in IIJS Premiere 2021 at BIEC Bangalore will also be considered for 1 booth (9 sqm) at IIJS Premiere 2022 booth allotment based on receipt of duly filled Online space application form for IIJS Premiere 2022 and 50% payments received on or before 16<sup>th</sup> May 2022.
- R. New companies interested to participate in the IIJS Premiere 2022 can apply for only 1 booth (9 sqm) through this Online space application form along with 50% payments on or before 16<sup>th</sup> May 2022, the allotment of which will be based on availability & the membership type.
- S. Members can apply for as many booths as interested, in the first edition of IIJS Tritiya 2023, as per the package of 3 show application form along with submission of the respective payments for the same on or before 16<sup>th</sup> May 2022.
- T. Mandatory Safe for all exhibitors: Due to limited space at the venue, all the exhibitors are requested to take note that no strong room facility will be available. All the exhibitors must compulsorily apply for safe. Details will be shared in the online exhibitor manual.
- U. Fresh allotment for all the applicants will be done for IIJS Premiere 2022 irrespective of your booth location at IIJS Premiere 2021.
- V. Allotment will be done through a lottery system for IIJS Premiere 2022, in the order of higher number to lower number of booths and as per your membership type as per 30<sup>th</sup> April 2022 (Ordinary/MSME/Associate). Kindly refer to the allotment guidelines attached as a link in the mail below
- W. ONLY vaccinated people will be allowed at the IIJS Premiere 2022.
- X. Adherence to the guidelines and rules pertaining to COVID 19 as issued and mandated by the Central and State Govt. is a must. Installation of the Arogya Setu App on your mobile device is mandatory for entry to the site at all times.

- Y. *In case, if any applicant is under a continuous 3, 2, or 1-years waiting list & their name is not mentioned under Annexure I, II & III, then they may immediately inform us by e-mail/fax/letter with the records of the last 3, 2 or 1 years not later than Tuesday, 16th May 2022.*
- Z. Applicants may note that all official communication from GJEPC for IJS Premiere 2022 will be done only through emails (from [ijjs@gjepcindia.com](mailto:ijjs@gjepcindia.com)), primarily at the email address notified under membership user. There will be no other medium of communication in this regard.
- AA. The allotment of booths for all the applicant members (pan India) will be held at a centralized location in Mumbai on a stipulated date. Regional Applicants can be present at GJEPC Regional Offices as per the details mentioned in the allotment schedule that will be circulated later.
- BB. The exact dates & schedule of allotment along with the criteria will be announced to all the applicants' individually through email and announced simultaneously on <https://gjepc.org/ijjs-premiere/>. Please note that communication in no other form will be made with regards to the final schedule of booth allotment.
- CC. The decision of the organizers with regards to allotment will be final & binding on all the applicants.
- DD. Please read the cancellation policy carefully before applying. The cancellation charges will be as under:

2	From the day of booth allotment to the beginning of the show	100%

**Points to Note:**

- EE. In case any member who has applied for all the 3 shows & cancels any of the show after IJS Premiere 2022, then the advance amount of 25% paid will be forfeited.
- FF. In case any member who has applied for all the 3 shows & cancels any or all 3 shows, then the 50% cancellation on IJS Premiere 2022 will be applicable. The advance amount for IJS Signature 2023 & IJS Tritiya 2023 will be refunded, without any interest thereof.
- GG. Please note that the Council reserves all the rights to postpone or cancel the show completely or partially without any prior intimation, subject to the changes in the Govt. rules and regulations and any such changes thereof for organizing the show, including based on its perception of the COVID 2019 situation in the venue/city/state/country, whether Govt. issues any regulation, in the interest of the participants and visitors. In case of such a situation and for any matter beyond the reasonable control of the Council, including, but not limited to, the force majeure events, causing any delay/ failure to organize the show or cancellation of any facility/attribute/service or the entire show, the Council shall not accept any responsibility or indemnity, whatsoever, and under no circumstance shall the Council have any liability to the applicant/participant for any loss or damage of any kind whatsoever incurred as a result of the postponement or cancellation of the show.

**PLEASE NOTE:**

**Renting, Subletting & Sharing of booths:** The Exhibitors shall not transfer, dispose of part with or otherwise sublet the whole or part of its Booth, whether for financial consideration or otherwise. The exhibitor must, if he is an agent, distributor or licensee, state at the time of submitting the Application the names or principals to be represented. This does not prohibit an Exhibitor displaying the products of a principal for whom it is acting as an agent, distributor, or sole licensee with the prior written permission from the Council. Further, if any Exhibitor or its representatives allows any other exhibitors or its representative in its booth without proper identification and badges allocated to that particular booth by the Council, then such activity would be considered as sub-letting by the exhibitor and appropriate disciplinary action may be taken against such Exhibitor and its representatives by the Council.
