- b. Diamond, Gemstone & Other Studded Jewellery
- c. Silver Jewellery, Artefacts & Gifting Items
- d. Jewellery Findings
- e. Loose Stones & CVD
- f. Laboratories & Education

The allotment of the applicants will be based on their GJEPC Membership status as of 15th September 2022

Allotment of Preference to Applicants in each category will be as per below:

GENERAL PREFERENCES FOR EVERY CATEGORY

- A. Ordinary Members will have 1st preference in the allotment of booths.
- B. Members having manufacturing units registered under Udhdyog Aadhar Number (UAN) / SSI with the Council will get 2nd preference in booth allotment.
- C. Associate Member will get the 3rd preference in each respective category of allotment/s.

The chronological order for allotment will be as follows:

- a. Less Area
- b. Same Area Different Location
- c. More Area
- d. New applicants

Benefits of participating in all 3-show combo packages (Not applicable for Machinery and allied):

- 1) Preference in booth allotment at IIJS Signature 2023 & IIJS Tiritiya 2023 (based on the membership type)
- 2) Retaining the same location of the stall at IIJS Signature 2023 as was in IIJS Premiere 2022 (subject to the number of Stalls applied for IIJS Signature 2023 is the same as was allotted at IIJS Premiere 2022)
- 3) Will get preferential pricing (Discount benefit) as mentioned in Table A above

Below are the scenarios of space application & subsequent benefits:

Scenario 1: Participating at all 3 shows with the same area in all 3 shows

- Preference in booth allotment at IIJS Signature 2023 & Tiritiya 2023
- Retaining the same location at IIJS Signature 2023 as was during IIJS Premiere 2022
- Preferential Pricing (Discount benefit), as mentioned in Table A above

Scenario 2: Participating at all 3 shows applying for same area in IIJS Premiere 2022 & IIJS Signature 2023 but different area at IIJS Tiritiya

- Preference in booth allotment at IIJS Signature 2023 & IIJS Tiritiya 2023 after the allotment of exhibitors applying for same area in all 3 shows (scenario 1)
- Retaining same location at IIJS Signature 2023 as was during IIJS Premiere 2022
- Preferential Pricing (Discount benefit) as mentioned in Table A above

Scenario 3: Participating at all 3 shows applying for different area in all the 3-shows

- Preference in booth allotment at IIJS Signature 2023 & IIJS Tiritiya 2023 after the allotment of exhibitors applying for same area in IIJS Premiere 2022 & IIJS Signature 2023 but different area in IIJS Tiritiya 2023 (scenario 2)
- Preferential Pricing (Discount benefit), as mentioned in Table A above

Scenario 4: Participating at any 1 or 2 shows

- Booth allotment after the allotment of exhibitors applying for different area at all 3-shows (scenario 3)
- No preferential pricing benefits

Members are informed that application for more areas does not guarantee confirmed allotment. The no of booths to be allotted to applicants will be based as per application submitted & booths will be allotted as per the availability.

Guidelines:

- D. Please note that application and allotment of more / less area are limited to the shows mentioned in FY. 2022-2023 Only.
- E. **Online Space Application:** All applicants are required to compulsorily submit the online space application form before **15th September 2022**, and send the application, payment, and declaration to complete their participation formalities.
- F. **Display of Products:** The display of Loose Diamond & Color stones in the Jewellery Section is not allowed. Similarly, No Jewellery in Loose Diamonds & Color stones Section will be allowed. (Beads in Mala form will be allowed in the Loose stones section)
- G. **Booth Allotment:** Booth allotment will be undertaken section-wise & from higher to lower space as per availability and through a lottery basis. No further changes/modifications in space will be accepted after submission of the online space application form and before booth allotment.

Points to Note:

- H. Renewal/Application of Membership for FY 2022-23 is mandatory to be completed by 30th April 2022. Mere submission of the online space application form and submission of payment without renewal of membership does not qualify any company to become a bonafide exhibitor and their participation will be cancelled.
- I. All the stalls at IIJS Signature 2023, and IIJS Tiritiya 2023 Bangalore will be built-in stalls in the **Maxima** system.
- J. No RAW space / Duplex Stalls options will be there/allowed to be built.
- K. Members can apply for as many booths as interested, in the first edition of IIJS Tiritiya 2023 Bangalore.
- L. Mandatory Safe for all exhibitors: Due to limited space at the venue, all the exhibitors are requested to take note that no strong room facility will be available. All the exhibitors must compulsorily apply for safe. Details will be shared in the online exhibitor manual.
- M. Fresh allotment for all the applicants will be done for IIJS Signature 2023 irrespective of your booth location at IIJS Signature 2022.
- N. Allotment will be done through a lottery system for IIJS Signature 2023, in the order of higher number to lower number of booths and as per your membership type (Ordinary/MSME/Associate).
- O. Adherence to the guidelines and rules pertaining to COVID 19 as issued and mandated by the Central and State Govt. is a must. Installation of the Arogya Setu App on your mobile device is mandatory for entry to the site at all times.
- P. Applicants may note that all official communication from GJEPC for IIJS will be done only through emails (from iijs@gjepcindia.com), primarily at the email address notified under membership user. There will be no other medium of communication in this regard.
- Q. The allotment of booths for all the applicant members (pan India) will be held at a centralized location in Mumbai on a stipulated date. Regional Applicants can be present at GJEPC Regional Offices as per the details mentioned in the allotment schedule that will be circulated later.
- R. The exact dates & schedule of allotment along with the criteria will be announced to all the applicants' individually through email and announced simultaneously on <https://gjepc.org/iijs-signature/> Please note that communication in no other form will be made with regards to the final schedule of booth allotment.

- S. The decision of the organizers with regards to allotment will be final & binding on all the applicants.
- T. Due to any reason, not in the control of the Council, if the venue is unable to provide Council a particular hall #, as was utilised for IJS Premiere 2022, a reallocation will be done for the exhibitors of that particular hall as per the displacement norms followed by the Council.
- U. Please read the cancellation policy carefully before applying. The cancellation charges will be as under:

For IJS Signature 2023

- a. If cancelled at any time between 16th September to 02nd October 2022, 25% of the total Participation Cost shall be deducted and the remaining 75% of the Participation Cost shall be refunded
- b. If cancelled at any time between 03rd October to 03rd November 2022, 50% of the total Participation Cost shall be deducted and the remaining 50% of the Participation Cost shall be refunded
- c. If cancelled at any time between 04th November to 04th December 2022, 75% of the total Participation Cost shall be deducted and the remaining 25% of the Participation Cost shall be refunded
- d. If cancelled at any time after 05th December 2022 then 100% of the total Participation Cost shall be forfeited by the Council

For IJS Tiritiya 2023 Bangalore

- a. If cancelled at any time between 16th September to 14th December 2022, 25% of the total Participation Cost shall be deducted and the remaining 75% of the Participation Cost shall be refunded
- b. If cancelled at any time between 15th December 2022 to 15th January 2023, 50% of the total Participation Cost shall be deducted and the remaining 50% of the Participation Cost shall be refunded
- c. If cancelled at any time between 16th January to 16th February 2023, 75% of the total Participation Cost shall be deducted and the remaining 25% of the Participation Cost shall be refunded
- d. If cancelled at any time after 17th February 2023 then 100% of the total Participation Cost shall be forfeited by the Council

Points to Note:

Please note that the Council reserves all the rights to postpone or cancel the show completely or partially without any prior intimation, subject to the changes in the Govt. rules and regulations and any such changes thereof for organizing the show, including based on its perception of the COVID 2019 situation in the venue/city/state/country, whether Govt. issues any regulation, in the interest of the participants and visitors. In case of such a situation and for any matter beyond the reasonable control of the Council, including, but not limited to, the force majeure events, causing any delay/ failure to organize the show or cancellation of any facility/attribute/service or the entire show, the Council shall not accept any responsibility or indemnity, whatsoever, and under no circumstance shall the Council have any liability to the applicant/participant for any loss or damage of any kind whatsoever incurred as a result of the postponement or cancellation of the show.

PLEASE NOTE:

Renting, Subletting & Sharing of booths: The Exhibitors shall not transfer, dispose of part with or otherwise sublet the whole or part of its Booth, whether for financial consideration or otherwise. The exhibitor must, if he is an agent, distributor or licensee, state at the time of submitting the Application the names or principals to be represented. This does not prohibit an Exhibitor displaying the products of a principal for whom it is acting as an agent, distributor, or sole licensee with the prior written permission from the Council. Further, if any Exhibitor or its representatives allows any other exhibitors or its representative in its booth without proper identification and badges allocated to that particular booth by the Council, then such activity would be considered as sub-letting by the exhibitor and appropriate disciplinary action may be taken against such Exhibitor and its representatives by the Council.
