Allotment Procedures: Jewellery, Loose Stones and Allied & Lab Section (BEC)

Order of Preference to Applicants:

- **1.** Ordinary Members will have **1**st preference in the allotment of booths.
- 2. Members having manufacturing units registered under Udhyog Aadhar Number (UAN) / SSI with the Council will get 2nd preference in booth allotment.
- 3. Associate Member will get the 3rd preference in each respective category of allotment/s.

<u>The allotment of the applicants will be based on their GJEPC Membership status as on 30th</u> <u>April 2019</u>

4. Last year Exhibitors (IIJS 2018)

5. First Preference: Auto Allotment (Retained)

AUTOMATIC allotment to those companies who are retaining the same area and location as held in IIJS 2018 WITHOUT any changes including the booths / location identified as mezzanine booths and relocation offered displaced companies

6. <u>Second Preference: Surrendering Partial Space</u> Allotment to Companies who surrender back partial space at existing location.

7. Third Preference: Displaced/Dislocated

Allotment to Companies who are displaced/dislocated due to changes in the floor plan. The preference in allotment will be based type of membership as mentioned above

8. Fourth Preference: Change in Location / Area

Allotment to those companies who submit change of location or area. The order of preference for allotment will be as follows:

- 9. Companies opting for LESS space than occupied by them at IIJS 2018. The order of allotment will be:
 - i. Ordinary Members
 - ii. Members under Udhyog Aadhar Number (UAN) / SSI / MSME
 - iii. Associate Members
- 10. Companies **opting for SAME space** as occupied by them at IIJS 2018 but requested for a change in location. The order of allotment will be:
 - i. Ordinary Members
 - ii. Members under Udhyog Aadhar Number (UAN) / SSI / MSME
 - iii. Associate Members
- 11. Companies **opting for MORE space** as occupied by them at IIJS 2018 as per below mentioned table. The order of allotment will be:
 - i. Ordinary Members
 - ii. Members under Udhyog Aadhar Number (UAN) / SSI / MSME
 - iii. Associate Members

In case of more area sought, the order of preference will be based on least to highest no. of increase in booths sought by the exhibitor, i.e. if one calls for 4 to 8 booths (4 booth increase) will get preference over exhibitors who will seek increase from 2 to 8 (6 booths increase sought) and so on.

Members are informed that mere application for more area does not guarantee confirmed allotment. The no of booths to be allotted to applicants will be based on the overall application received & available booths.

- 12. <u>Allotment of Waitlisted (Refer Annexure IV & V): The allotment of the waitlisted applicants will be based on</u> <u>their GJEPC Membership status as on 30th April 2019</u>
 - All the Ordinary Members of GJEPC with Udhyog Aadhar Number (UAN) / SSI / MSME & under waitlist till IIJS 2018 will be given 1st preference in allotment.
 - II. All the Ordinary Members of GJEPC under waitlist till IIJS 2018 will be given 2nd preference in allotment.
 - III. Members under Udhyog Aadhar Number (UAN) / SSI / MSME will get 3rd preference.
 - IV. Associate members under waitlist till IIJS 2018 will get 4th preference in allotment

13. Allotment of Fresh Applicants (Applying for the first time at IIJS 2019)

Fresh Applicants will be allotted booth after the allotment of waitlisted applicants. The allotment of the Fresh

Applicants will be based on their GJEPC Membership status as on 30th April 2019. The allotment preference will be

as under:

- All the Ordinary Members of GJEPC with Udhyog Aadhar Number (UAN) / SSI / MSME & under waitlist till IIJS 2018 will be given 1st preference in allotment.
- II. All the Ordinary Members of GJEPC under waitlist till IIJS 2018 will be given 2nd preference in allotment.
- III. Members under Udhyog Aadhar Number (UAN) / SSI / MSME will get 3rd preference.
- IV. Associate members under waitlist till IIJS 2018 will get 4th preference in allotment

Allotment for multiple applicants within each section will be undertaken through lottery basis, wherever applicable.

Guidelines:

- Online Space Application: All applicants are required to compulsorily submit the online space application form before Saturday, 11th May 2019 and send application, payment and declaration to complete their participation formalities.
- 15. **Display of Products:** Display of Loose Diamond & Color stones in Jewellery Section is not allowed. Similarly, No Jewellery in Loose Diamonds & Color stones Section will be allowed. (Beads in Mala form will be allowed in Loose stones section)
- 16. **Booth Allotment:** Booth allotment will be undertaken section-wise & from higher to lower space as per availability and through lottery basis. No further changes/modification in space will be accepted after submission of online space application form and before booth allotment.
- 17. Penalty Charges for late submission of Online Space Application: In case any applicant, who has participated at <u>IIJS for 3 years or more (from IIJS 2018 & before)</u>, misses out on the submission by **Saturday 11th May 2019** (stipulated deadline) then they will have an option to submit the same by an **extended deadline of Tuesday, 14th May 2019**. However, 10% security deposit paid along with the participation cost will be forfeited as penalty for late application. Allotment of all such applicants will be done after the allotment of booths exhibitors who have applied within the deadline. There will be no further extension available for such applicants and their booths will be released to the waitlisted applicants without any further notice. It may be noted that in view of the huge waiting list of new applicants, there will be no availability of space/area in the floor plan in case extended deadline is missed. Late application is not permitted to all such exhibitors that have been participants at IIJS for less than 3 years.

Points to Note:

- 18. Renewal/Application of Membership for FY 2019-20 is mandatory to be completed by 30th April 2019. Mere submission of the online space application form and submission of payment without renewal of membership does not qualify any company to become a bonafide exhibitor and their participation will be cancelled.
- 19. New applicants would be considered for a maximum of 9 sqmt. Stalls only.
- 20. Exhibitor cannot have booth at multiple location within Jewellery or Loose stones section.
- 21. Exhibitors who have participated in IIJS 2018 may apply for more space as mentioned in Circular of Space application.

- 22. All Premium, Corner, Island and Mezzanine booths are marked on the floor plan. Please refer to the legends & premium charges earmarked on the floor plan. In case of any further assistance, please do not hesitate to call on <u>1800-103-4353</u>
- 23. In case, if any applicant is under continuous 2- or 1-years waiting list & their name is not mentioned under Annexure III & IV, then they may immediately inform us by e-mail/fax/letter with the records of last 2 or 1 years not later than 10th May 2019.
- 24. Applicants may note that all official communication from GJEPC for IIJS 2019 will be done only through emails, primarily at the email address notified under membership user. There will be no other medium of communication in this regard.
- 25. The allotment of booths for all the applicant members (pan India) will be held at a centralized location in Mumbai on a stipulated date. Regional Applicants can be present at GJEPC Regional Offices as per the details mentioned in the allotment schedule that will be circulated later.
- 26. The exact dates & schedule of allotment along with the criteria will be announced to all the applicants' individually through email and also announced simultaneously on <u>www.iijs.org</u> Please note that communication in no other form will be made with regards to the final schedule of booth allotment.
- 27. The decision of the organizers with regards to allotment will be final & binding on all the applicants.
- 28. <u>NON-PARTICIPATION CLAUSE</u>: In view of the long list of applicants for IIJS with years in waiting and other opportunities available during the same period in Mumbai, the Council intends to create opportunity to the maximum number of members by way of introducing the non-participation clause in its space application form. According to the said clause the exhibitor will not be able to directly or indirectly apply or participate or exhibit in any show or exhibition or fair which is similar to exhibitions or shows related to gem & Jewellery within Mumbai or Greater Mumbai limits or vice versa for a period of 1 week before the start of IIJS 2019 and 1 week after the completion of IIJS 2019. This will greatly increase the options of all applicants to participate either in IIJS or other similar shows or exhibitions or fairs during the same period. Further, in case any exhibitor is found violating this clause, then disciplinary action will be initiated against such exhibitor, which will include immediate closure of the booth of the exhibitor at IIJS 2019 and/or the said exhibitor will lose the chance to exhibit or participate at all future events of the Council and/or black listed/debarred from all the activities of Council.
