Terms and Conditions:

- i. All Risk cover (At Show + Transit + Terrorism + Infidelity of Service Provider) is available at the rate of 0.04%. This needs to be paid for in advance. Minimum 2 CCTV cameras along with DVR mandatory At Show for All Risk cover.
- ii. If shippers use their own Insurance, then a subrogation waiver copy must be submitted before the pickup. If a subrogation waiver is not received in such a case 0.025% will be charged as a handling charge.
- iii. Cover for Infidelity by service provider is available at the rate of 0.02%. This needs to be paid for in advance.
- iv. Logistics charges for to and from movement need to be paid in advance.
