#### Membership Renewal:

Renewal/Application of Membership for FY 2024-25 is mandatory to be completed starting from 1<sup>st</sup> April 2024. Submission of the online space application form and submission of payment without renewal of membership from 1<sup>st</sup> April, 2024 does not qualify any company to become a bonafide applicant and hence their application/participation will be rejected/cancelled.



The allotment of the applicant(s) will be based on their GJEPC Membership status as of 15th May 2024.

Allotment of Preference to Applicant(s) in each category will be as per the below:

General Preferences for every category (participants of IIJS shows of 2024-25 for each show separately and new participants)

- Ordinary Members will have 1st preference in the allotment of booths.
- Members having manufacturing units registered under Udyog Aadhar Number (UAN) / SSI with the Council will get 2<sup>nd</sup> preference in booth allotment.
- Associate Member will get the 3<sup>rd</sup> preference in each respective category of allotment/s.

Applicant(s) may please note that to avail the DISCOUNT BENEFIT OFFER, participation at IIJS Tritiya 2025 is mandatory for 3 show and participation at IIJS Tritiya 2026 is mandatory for 6 shows, the discount as per the area allotted will be credited post the invoicing of the third show i.e., IIJS Tritiya 2025 & after invoicing of IIJS Tritiya 2026.

#### **Guidelines:**

- Please note that application and allotment of more / less area are limited to the shows mentioned in FY. 2024-2026 Only.
- Online Space Application: All applicants are required to compulsorily submit the online space application form on or before 15th May 2024, and send the application, payment, and declaration to complete their participation formalities.
- **Display of Products:** The display of Loose Diamond, Lab grown diamond & Color stones in the Jewellery Section is not allowed. Similarly, No Jewellery in Loose Diamonds, Lab grown diamond & Color stones Section will be allowed. (Beads in Mala form will be allowed in the Loose stones section)
- **Booth Allotment:** Booth allotment will be undertaken section-wise & from higher to lower space as per availability and through a lottery system. No further changes/modifications in space will be accepted after submission of the online space application form and before booth allotment.
- Renewal/Application of Membership for FY 2024-25 is mandatory to be completed from 1<sup>st</sup> of April, 2024 onwards before applying for the stall. Submission of the online space application form and submission of payment without renewal of membership does not







qualify any Company to become a bonafide exhibitor and their participation will be rejected/cancelled.

- All the stalls at IIJS Premiere 2024-25, IIJS Signature 2025-26 and IIJS Tritiya 2025-26 will be built-in stalls in the Maxima system (Shell type). For the convenience of exhibitors, it has been decided that no option for RAW space / Duplex Stalls will be allowed to build in all the IIJS shows.
- Existing members/New applicant can apply for as many booths as they are interested. However new applicants at IIJS are generally offered single booth (9/12/16 Sqmtr). It may be noted that in case of application for additional booth request by existing exhibitors and application of booth/s by new applicants, the booths will be allocated strictly subject to availability.
- Companies that participated at IIJS Premiere 2023, IIJS Signature 2024 & IIJS Tritiya 2024 and wish to retain the same area and
  location (except dislocated stalls) will be allotted stalls based on the application for the same area, and application for the same is
  received before deadline of 15th May 2024.
- Any application received after the deadline will lose their preference/ penalties may be applicable, as stipulated by competent authorities, for keeping the preference after the deadline.
- Mandatory Safe for all exhibitors: Due to limited space at the venue, all the exhibitors are requested to take note that no strong
  room facility will be available at the venue. Hence all the exhibitors must compulsorily apply for safe. Details will be duly shared in
  the online exhibitor manual which will be published shortly.
- Allotment will be done through a lottery system, in the order of higher number to lower number of booths and as per the membership type (Ordinary/MSME/Associate).
- Applicants may note that all official communication from GJEPC for IIJS will be done only through emails (from iijs@gjepcindia.com), primarily at the email address notified under membership user. There will be no other medium of communication in this regard and no correspondences/reasoning complaints on this matter will be entertained. In case of any change, the same may be indicated in the membership application form or during renewal of membership.
- The allotment of booths for all the applicant members (Pan India) will be held at a centralized location in Mumbai on a stipulated date. Regional Applicants can be present at GJEPC Regional Offices as per the details mentioned in the allotment schedule that will be circulated later.
- The exact dates & schedule of allotment along with the criteria will be announced to all the applicants' individually through email and announced simultaneously on <a href="https://gjepc.org">https://gjepc.org</a> Please note that communication in no other form will be made with regards to the final schedule of booth allotment.
- The decision of the organizers with regards to floor plan (inclusive of revisions, if any) and allotment will be final & binding on all the applicants.
- Due to any reason, not in the control of the Council, if the venue is unable to provide Council a particular hall #, for IIJS Premiere 2024-25, IIJS Signature 2025-26 & IIJS Tritiya 2025-26, a reallotment will be done for the exhibitors of that particular hall as per the displacement norms followed by the Council.

### **Points to Note:**

Please note that the Council reserves all the rights to postpone or cancel the show completely or partially without any prior intimation, subject to the changes in the Govt. rules and regulations and any such changes thereof for organizing the show, including based on its perception of the COVID 2019 situation in the venue/city/state/country, whether Govt. issues any regulation, in the interest of the participants







and visitors. In case of such a situation and for any matter beyond the reasonable control of the Council, including, but not limited to, the force majeure events, causing any delay/ failure to organize the show or cancellation of any facility/attribute/service or the entire show, the Council shall not accept any responsibility or indemnity, whatsoever, and under no circumstance shall the Council have any liability to the applicant(s)/participant(s) for any loss or damage of any kind whatsoever incurred as a result of such postponement or cancellation of the show.

#### **OTHER TERMS & CONDITIONS**

- No counter sale will be permitted during the Exhibition: As per the existing rules, if any Exhibitor is found selling any goods, the Council shall take such action as it deems fit including debarring the said Exhibitor from participating in the Exhibition and any future exhibitions which may be organized by the Council from time to time.
- In case of any sort of payment is pending/outstanding from the applicant(s) / exhibitor(s), the Council reserves the right to disqualify such applicant(s) / exhibitor(s) from the participation at any of the IIJS show(s).
- In case of any such instance where it comes to the attention of the Council that an exhibitor has procured a pass/badge under the Visitor category for its own representative by utilizing the name of a non-participating company and such person holding a visitor category pass/badge is found manning the exhibitor's booth during any time of the exhibition dates, then suitable action shall be taken by the Council against the said exhibitor as well as the holder of the visitor badge including but not limited to cancellation of booth for that exhibition & debarment from participation in any future shows which may be organized by GJEPC for both the companies involved thereof.
- In case it is discovered that a visitor enters the Exhibition holding an exhibitor badge and conducts any commercial activity as an
  Exhibitor, then suitable action shall be taken by the Council as it deems fit against the said person as well as the company who
  has issued the Exhibitor badge.

#### **RENTING, SUBLETTING & SHARING OF BOOTHS:**

The Exhibitor(s) shall not transfer, dispose of part with or otherwise sublet the whole or part of its Booth, whether for financial consideration or otherwise. The exhibitor must, if he is an agent, distributor or licensee, state at the time of submitting the Application the names or principals to be represented. This does not prohibit an Exhibitor displaying the products of a principal for whom it is acting as an agent, distributor, or sole licensee with the prior written permission from the Council. Further, if any Exhibitor or its representatives allows any other exhibitors or its representative in its booth without proper identification and badges allocated to that particular booth by the Council, then such activity would be considered as sub-letting by the exhibitor and appropriate disciplinary action may be taken against such Exhibitor and its representatives by the Council.

#### **EQUITABLE OPPORTUNITY CLAUSE:**

Any member/exhibitor shall not directly or indirectly participate/exhibit at any fair/show/exhibition of any form or nature, related to gems & jewellery, within the city limits where the IIJS is organized which is similar in nature to IIJS for a period of 30 days before the start and 15 days after the completion of IIJS. In case any member who is a participant/exhibitor at IIJS is found violating this clause, then disciplinary action will be initiated against such member/exhibitor, which will include immediate closure of the booth of the member/exhibitor and/or the said member/exhibitor will lose the chance to exhibit or participate at all future events of the Council and/or be blacklisted/debarred from all the future activities of Council.
