- ✦ Visitors need to enter PAN detail & confirm their registration & need to agree to visit the show on pre-defined date based on their Company or Retail showroom name & submit their Covid-19 Negative report to get the final activated badge.

- Covid-19 Report which is submitted should not be earlier than 72 hrs of your first scheduled entry at IJS Signature 2021.

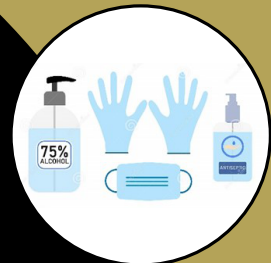
