

ANNEXURE - I

1. Opportunities for expansions: This year GJEPC have given expansion opportunity to its members and more thrust given to smaller exhibitor from 1/2/3 booths to up to 4 booths further Gold Jewellery section has been allocated more area to cater to the greater demand of the industry. All exhibitors who have participated in IIJS 2016 having the following opportunity for an expansion.

I. **Expansion of space on ground location & Change of Location:** Exhibitors who have participated in IIJS 2016 may apply for more space as mentioned below further they can apply for change of section from Couture/Mass Produced to Plain Gold Jewellery section only. However the allocation of space will be as per allotment rules and regulations.

II. **Opportunity to create Mezzanine Booth at Existing locations:** Few existing non-Mezzanine locations on the floor plan may be permitted to create Mezzanine stalls and expand vertically.

In view of this new development, only 8/6/5/4 non-mezzanine stall can be identified as Mezzanine stalls and we further request you to kindly send us a formal response as per below options: (allocation of the same will be subject to approval of Council)

- I want to retain the existing location and WANT to erect Mezzanine stalls
- I want to retain the existing location and DO NOT WANT to erect Mezzanine stalls

2. Optimization of Space inside Halls (Displacement & Re-Location): The floor plan has been realigned to have clear aisle and easy navigation due to which few booth locations have been rearranged & displaced as a result we have further added 167 new booths on the existing floor plan. Exhibitor may opt for retain the proposed location or may apply for change of location under lottery system. Please refer **Annexure II** for details of such exhibitors. Please find below the overall summary of new additions at IIJS 2017:

3. Re-Location of Synthetics & Simulants Section in Hall 5 (Open Bay): The Synthetics & Simulants Section has been relocated in Hall 5 (Open Bay). Allotment to all applicants will be done on lottery basis from higher to lower number of stalls.

4. Re-Location of International Jewellery Section in Hall2: The International Jewellery Section has been relocated in Hall 2

5. New Applicants: In all product sections, new applicants will be allotted space/area through lottery system for a maximum of one booth in respective section. Preference will be given to those applicants who were waitlisted continuously for continuously for 3 consecutive years in 2014, 2015 & 2016 as detailed in **Annexure III**, applicants who were waitlisted continuously for 2 consecutive years in 2015 & 2016 as detailed in **Annexure IV** & to those applicants who were waitlisted for 1 year in 2016 as detailed in **Annexure V** respectively.

6. Addition of new clause for participation at IIJS 2017: In view of the long list of applicants for IIJS with years in waiting and other opportunities available during the same period in Mumbai, the Council intends to create opportunity to the maximum number of members by way of introducing the **Limited Opportunity clause** in its space application form. According to the said clause **the exhibitor will not be able to directly or indirectly (including Group/Sister Concern/ common partner) apply or participate or exhibit in any show or exhibition or fair which is similar to exhibitions or shows, related to gem & jeweller, within Mumbai or Greater Mumbai limits or vice versa for a period of 1 week before the start of IIJS 2017 and 1 week after the completion of IIJS 2017.** This will greatly increase the options of all applicants to participate either in IIJS or other similar shows or exhibitions or fairs during the same period based on the options chosen by our members. Further, in case any exhibitor is found violating this clause, then disciplinary action will be initiated against such exhibitor, which will include immediate closure of the booth of the exhibitor at IIJS 2017 and/or the said exhibitor will lose the chance to exhibit or participate at all future events of the Council and/or black listed/debarred from all the activities of Council.

7. Lesser number of days for Stall construction: Please note days for constructing RAW space stall has been reduced. Kindly refer below for details.

8. G&J KYC Information Centre (GJKYC) compulsory for space application: Application of G&J KYC Information Centre (GJKYC) for FY 2017-18 is mandatory for GJEPC Members to apply for space application. For more information kindly contact 022 – 61156800 or logon to www.mykycbank.com.

9. Option to surrender partial space at Existing location: Like last year, exhibitors can opt to surrender their partial space from existing location and retain participation which includes:

- I. Mezzanine Booths: Exhibitors having 8+8 configuration can surrender back 4+4 configuration and retain the existing location.
- II. Non-Mezzanine Booths: Exhibitors having booth configuration of 8, 6, 4, 3 or 2 also have an option to surrender back partial space in any multiple of 9 sq.mts. and retain the existing location.

10. Compulsory Shell Scheme Booth for expansion from 9 sq.mts to 18 sq.mts: Exhibitors who may be getting expansion of space from 9 sq.mts to 18 sq.mts in IIJS 2017, in all such cases exhibitor’s booths will be created by GJEPC under shell scheme booths only.

In order to ease out issues of non- professional contractors and booth construction deferrals beyond the permitted timeline and with a view to operationalise compact timelines, the management has decided that from **IIJS 2018 onwards all participants having booth space of 9 sq.mts & 18 sq.mts will be compulsorily provided with specially designed Shell Scheme booths only**, There will be no scope of raw space construction by private contractors for such stall holders.
