<u>Subject:</u> GJEPC is planning to organise Virtual B2B meeting with prospective trade partners of gem & jewellery products in Switzerland to mitigate the impact of the disrupted supplies.

This is with reference to Covid-19 outbreak, it has been noted that imports of gem and jewellery products by various countries from Hong Kong and China has been disrupted.

In this regard, the GJEPC is of view that to mitigate this impact, one of the ways which may be explored is the possibility of exporting gold jewellery and polished diamonds products to Switzerland directly as the country is sourcing these products from Hong Kong and China in significant quantum (Table-1).

Switzerland also imports CGS from HK while not from China and silver jewellery neither from HK nor from China.
