Further, Rule 18.1 of the Election Rules of the Council, **"In case only one valid nomination is received for any Vacancy, then there will be no election for that vacancy/post."**

In terms of such provision, no elections shall be conducted for the below mentioned posts/seats:

- 1). Diamond Panel - Status Holder Category (EH/SEH/TH/STH/PTH) (01 Seat)
- 2). Synthetic Stones / Costume/Fashion Jewellery / Sales to Foreign Tourist -Status Holder Category (EH/SEH/TH/STH/PTH) (01 Seat)
- 3). Lab grown Diamond-Status Holder Category (EH/SEH/TH/STH/PTH) (01 Seat)
- 4). Gold Jewellery Panel & Other Precious Metal Jewellery Panel - General Category (01 Seat)
- 5). Silver Jewellery Panel- General Category/Women En/Young ent/start up/north east hill region Category (01 Seat)
- 6).Rajasthan Region- MSME Category (01 Seat)

Therefore, Elections will be conducted for the following posts only:-

- 1). Diamond Panel -MSME category: (02 seats)**
- 2). Special Economic Zone(SEZ) Panel -MSME category: (01 Seat)**
- 3). Studded Jewellery Panel -Status Holder Category (EH/SEH/TH/STH/PTH) (01 Seat)**

#### **ELIGIBILITY TO VOTE**

- (a) The Voting will be done through Electronic voting process only.
- (b) Electronic Voting is open only to the eligible Ordinary and Associate voter members. The voter list is displayed on the GJEPC website [www.gjepc.org](http://www.gjepc.org) (members only section)
- (c) The Eligible members shall have right to vote for the abovementioned posts (as per Article 4.1 of the Articles of Association)
- (d) Only the authorized representative as described in Article 10 of AoA and whose name is mentioned as such in the membership application, while applying for membership with the GJEPC, shall have right to vote at the Election.

- (e) Each eligible member as per Article 4.1 of AoA of the GJEPC shall have one vote for every single representation/seat for the respective panel/panel group as per the panel/panel group opted/ registered with the GJEPC during registration/renewal of membership or changed through subsequent communication being effective within stipulated time period as per Article 10(f) of AoA. (For example, if a particular panel/ panel group has two vacancies, each member of the GJEPC who is registered for that panel/panel group shall have one vote for each representation/ seat in that panel/panel group but not exceeding two votes in all).

## **PROCEDURE FOR ONLINE ELECTRONIC VOTING**

1. The duration of online e-voting shall commence from 9.30 a.m on Thursday, 11<sup>th</sup> September 2025 and continue till 5.00 PM on day, 17<sup>th</sup> September 2025.
2. Each voter Member shall follow the procedure of electronic voting which will be shared shortly on or before 10<sup>th</sup> September 2025.

In addition to the above Eligible voter members may like to note that the timeline/deadline for the voting process will be strictly adhered to and no request will be entertained for extension for the same due to any reason whatsoever.

The procedure (User manual) for Online Electronic Voting will be shared separately by National Securities Depository Limited (NSDL) on the registered email id as registered with the Council by the Voter members on or before 10<sup>th</sup> September 2025.
